A *BILL to amend and reenact §§ 23.1-3222, 23.1-3223, 23.1-3227, 23.1-3228, 46.2-749.2:2, and 58.1-344.3 of the Code of Virginia and to repeal §§ 23.1-3225 and 23.1-3226 of the Code of Virginia, relating to Virginia Commission for the Arts; Virginia Commission for the Arts Fund.*

Be it enacted by the General Assembly of Virginia:

1. That §§ 23.1-3222, 23.1-3223, 23.1-3227, 23.1-3228, 46.2-749.2:2, and 58.1-344.3 of the Code of Virginia are amended and reenacted as follows:

Article 7

Virginia Commission for the Arts and Virginia Arts Foundation.

§ 23.1-3222. Virginia Commission for the Arts established; purpose; membership.

A. The Virginia Commission for the Arts (the Commission) is established as a supervisory commission within the meaning of § 2.2-2100 in the executive branch of state government.

B. The Commission is designated the official agency of the Commonwealth to receive and disburse any funds made available to the Commonwealth by the National Endowment for the Arts *and the Fund pursuant to § 23.1-3227.*

C. The Commission shall consist of 13 members appointed by the Governor subject to confirmation by the General Assembly. No employee of the Commonwealth or member of the General Assembly is eligible for appointment as a member of the Commission. At least one but no more than two members shall be appointed from each congressional district in the Commonwealth.

D. Members shall be appointed for one term of five years; however, a member appointed to serve an unexpired term is eligible to serve a full five-year term immediately succeeding the unexpired term. Appointments to fill vacancies, other than by expiration of a term, shall be for the unexpired terms. Vacancies shall be filled in the same manner as the original appointments. No member who serves a full five-year term is eligible for reappointment during the five-year period following the expiration of his term.

E. The Commission shall elect a chairman from among its membership.

F. A majority of the members of the Commission shall constitute a quorum.

G. The members of the Commission shall receive no compensation for their services but shall be reimbursed for the reasonable and necessary expenses incurred in the performance of their duties as provided in § 2.2-2825.

H. *Any person designated by the board to handle the funds of the Commission shall give bond, with corporate surety, in a penalty fixed by the Governor, conditioned upon the faithful discharge of his duties. Any premium on the bond shall be paid from funds available to the Commission.*

§ 23.1-3223. Duties of the Commission.

A. The Commission shall:

1. Stimulate and encourage throughout the Commonwealth growth in artistic quality and excellence, public interest and participation in the arts, and access to high-quality and affordable ~~art~~ literary, visual, and performing arts for all Virginians;

2. Make recommendations concerning appropriate methods to encourage economic viability, an intellectually stimulating environment for artists, and participation in and appreciation of the arts to meet the legitimate needs and aspirations of persons in all parts of the Commonwealth;

3. Promote the development and implementation of a planned, sequential, and comprehensive program of arts education, taught by licensed teachers endorsed in arts education, in the public elementary and secondary schools of the Commonwealth;

4. Provide supplemental learning opportunities to the public school arts education curriculum;

5. Encourage the development of a network of professional arts organizations, the media, and arts promoters for the production of classical and new works of art and diversity in artistic expressions in media including the literary, visual, and performing arts;

6. Provide funding for and technical assistance to artists, recognized nonprofit arts organizations, and arts organizations and activities that celebrate and preserve the various cultures represented among the citizens of the Commonwealth;

7. Encourage and support the creation of new works of art, arts organizations whose primary

60 tours to increase the availability of this form of artistic expression throughout the Commonwealth;

61 8. Establish a program of financial assistance to provide scholarships, grants, and other awards to
62 artists who demonstrate exceptional ability and talent;

63 9. Establish an advisory panel composed of artists, arts administrators, and citizens to advise the
64 Commission concerning fiscal matters;

65 10. Encourage arts organizations to dedicate to their endowments at least \$1 of the price of each
66 adult admission to performances or exhibitions or at least one percent of moneys collected in fund
67 campaigns;

68 11. Encourage arts organizations to develop and implement endowment enlargement plans that yield
69 enough income to underwrite one-third of the organizations' annual operating costs;

70 12. Apply to and enter into contracts and agreements with the United States or any appropriate
71 agency or officer of the United States for participation in or receipt of aid *funding* from any federal
72 program respecting the arts;

73 13. Provide incentives to local governing bodies to encourage public support and funding of the arts;

74 14. Accept, *hold, and administer* gifts, contributions, and bequests of money or any other thing to be
75 used for carrying out the purposes of this article;

76 15. Develop specific procedures for the administration and implementation of a *grantmaking*
77 program, so long as any such program is for the benefit of a nonprofit organization qualifying as a
78 § 501(c)(3) organization under the Internal Revenue Code, ~~whereby interest earned on endowment funds~~
79 ~~donated to stimulate and encourage public interest and enjoyment of music and the performing arts may~~
80 ~~be matched by state funds appropriated for this program, and prepare written guidelines to govern such~~
81 ~~program; and~~

82 16. Administer any funds available to the Commission and disburse such funds in accordance with
83 the purposes of this article. ~~In allocating funds to be disbursed to arts organizations, the Commission~~
84 ~~shall give preferential consideration to arts organizations actively implementing an endowment~~
85 ~~enlargement plan either individually or as members of a regional consortium of arts organizations;.~~

86 17. *Make expenditures from the Fund's interest and income to promote the arts in the*
87 *Commonwealth in accordance with § 23.1-3228 and assist nonprofit arts and cultural institutions and*
88 *organizations in the Commonwealth to assess, enhance, and plan for enhancement of their fiscal*
89 *stability, financial management and control capabilities, and capacity to raise funds for the furtherance*
90 *of their respective missions from nongovernmental sources;*

91 18. *Enter into contracts and execute all instruments necessary and appropriate to carry out the*
92 *Commission's purposes;*

93 19. *Explore and make recommendations concerning other possible dedicated revenue sources for the*
94 *Fund; and*

95 20. *Perform any lawful acts necessary or appropriate to carry out the purposes of the Commission.*

96 B. Nothing in this article shall be construed to affect the statutory purposes of the Virginia Museum
97 of Fine Arts.

98 **§ 23.1-3227. Virginia Commission for the Arts Fund.**

99 A. There is created in the state treasury a special nonreverting fund to be known as the Virginia ~~Arts~~
100 ~~Foundation~~ *Commission for the Arts* Fund, referred to in this article as "the Fund." The Fund shall be
101 established on the books of the Comptroller.

102 B. The Fund shall include such funds as may be appropriated by the General Assembly; revenues
103 transferred to the Fund from the special license plates for Virginians for the Arts program pursuant to
104 § 46.2-749.2:2; voluntary contributions collected through the income tax checkoff for the arts pursuant to
105 subdivision B 8 of § 58.1-344.3; and designated gifts, contributions, and bequests of money, securities,
106 or property of any other character.

107 C. All money, securities, or other property designated for the Fund shall be paid into the state
108 treasury and credited to the Fund. Interest earned on moneys in the Fund shall remain in the Fund and
109 be credited to it. Any moneys remaining in the Fund, including interest thereon, at the end of each fiscal
110 year shall not revert to the general fund but shall remain in the Fund. Expenditures and disbursements
111 from the Fund shall be made by the State Treasurer on warrants issued by the Comptroller upon written
112 request signed by persons authorized by the ~~Foundation~~ *Commission*. The Fund's principal is not subject
113 to expenditure by the ~~Foundation~~ *Commission*.

114 **§ 23.1-3228. Gifts and bequests; exemption from taxation.**

115 Gifts and bequests of money, securities, or other property to the Fund, and the interest or income
116 from such gifts and bequests, are gifts to the Commonwealth, and the Fund is exempt from all state and
117 local taxes. Unless otherwise restricted by the terms of the gift or bequest, the ~~Foundation~~ *Commission*
118 may sell, exchange, or otherwise dispose of such gifts and bequests. The proceeds from such
119 transactions shall be deposited to the credit of the Fund. The ~~Foundation~~ *Commission* shall not actively
120 solicit private donations for the Fund; however, this limitation shall not prevent the ~~Foundation~~

Commission from actively encouraging financial support for the ~~Foundation~~ Commission through the special license plate and income tax checkoff programs. Notwithstanding any other provision of this section, the ~~Foundation~~ Commission may accept and solicit public and private contributions for the limited purpose of assisting nonprofit arts and cultural institutions and organizations in the Commonwealth to enhance the fiscal stability, financial management, and fundraising abilities of such organizations.

§ 46.2-749.2:2. Special license plates for Virginians for the Arts; fees.

A. On receipt of an application and payment of the fee prescribed by this section, the Commissioner shall issue special license plates bearing the following legend: VIRGINIANS FOR THE ARTS.

B. The annual fee for plates issued pursuant to this section shall be ~~twenty-five dollars~~ \$25 in addition to the prescribed fee for state license plates. For each such ~~twenty-five dollar~~ \$25 fee collected in excess of 1,000 registrations pursuant to this section, ~~fifteen dollars~~ \$15 shall be paid into the state treasury and credited to the special nonreverting fund known as the Virginia Arts Foundation Commission for the Arts Fund established within the Department of Accounts, for use by the Virginia Arts Foundation Commission for the Arts.

§ 58.1-344.3. Voluntary contributions of refunds requirements.

A. 1. For taxable years beginning on and after January 1, 2005, all entities entitled to voluntary contributions of tax refunds listed in subsections B and C must have received at least \$10,000 in contributions in each of the three previous taxable years for which there is complete data and in which such entity was listed on the individual income tax return.

2. In the event that an entity listed in subsections B and C does not satisfy the requirement in subdivision 1, such entity shall no longer be listed on the individual income tax return.

3. a. The entities listed in subdivisions B 21 and B 22 as well as any other entities in subsections B and C added subsequent to the 2004 Session of the General Assembly shall not appear on the individual income tax return until their addition to the individual income tax return results in a maximum of 25 contributions listed on the return. Such contributions shall be added in the order that they are listed in subsections B and C.

b. Each entity added to the income tax return shall appear on the return for at least three consecutive taxable years before the requirement in subdivision 1 is applied to such entity.

4. The Department of Taxation shall report annually by the first day of each General Assembly Regular Session to the Chairmen of the House Committee on Finance and Senate Committee on Finance and Appropriations the amounts collected for each entity listed under subsections B and C for the three most recent taxable years for which there is complete data. Such report shall also identify the entities, if any, that will be removed from the individual income tax return because they have failed the requirements in subdivision 1, the entities that will remain on the individual income tax return, and the entities, if any, that will be added to the individual income tax return.

B. Subject to the provisions of subsection A, the following entities entitled to voluntary contributions shall appear on the individual income tax return and are eligible to receive tax refund contributions of not less than \$1:

1. Nongame wildlife voluntary contribution.

a. All moneys contributed shall be used for the conservation and management of endangered species and other nongame wildlife. "Nongame wildlife" includes protected wildlife, endangered and threatened wildlife, aquatic wildlife, specialized habitat wildlife both terrestrial and aquatic, and mollusks, crustaceans, and other invertebrates under the jurisdiction of the Board of Wildlife Resources.

b. All moneys shall be deposited into a special fund known as the Game Protection Fund and which shall be accounted for as a separate part thereof to be designated as the Nongame Cash Fund. All moneys so deposited in the Nongame Cash Fund shall be used by the Board of Wildlife Resources for the purposes set forth herein.

2. Open space recreation and conservation voluntary contribution.

a. All moneys contributed shall be used by the Department of Conservation and Recreation to acquire land for recreational purposes and preserve natural areas; to develop, maintain, and improve state park sites and facilities; and to provide funds to local public bodies pursuant to the Virginia Outdoor Fund Grants Program.

b. All moneys shall be deposited into a special fund known as the Open Space Recreation and Conservation Fund. The moneys in the fund shall be allocated one-half to the Department of Conservation and Recreation for the purposes stated in subdivision 2 a and one-half to local public bodies pursuant to the Virginia Outdoor Fund Grants Program.

3. Voluntary contribution to political party.

All moneys contributed shall be paid to the State Central Committee of any party that meets the definition of a political party under § 24.2-101 as of July 1 of the previous taxable year. The maximum contribution allowable under this subdivision shall be \$25. In the case of a joint return of married

182 individuals, each spouse may designate that the maximum contribution allowable be paid.

183 4. United States Olympic Committee voluntary contribution.

184 All moneys contributed shall be paid to the United States Olympic Committee.

185 5. Housing program voluntary contribution.

186 a. All moneys contributed shall be used by the Department of Housing and Community Development
187 to provide assistance for emergency, transitional, and permanent housing for the homeless; and to
188 provide assistance to housing for the low-income elderly for the physically or mentally disabled.

189 b. All moneys shall be deposited into a special fund known as the Virginia Tax Check-off for
190 Housing Fund. All moneys deposited in the fund shall be used by the Department of Housing and
191 Community Development for the purposes set forth in this subdivision. Funds made available to the
192 Virginia Tax Check-off for Housing Fund may supplement but shall not supplant activities of the
193 Virginia Housing Trust Fund established pursuant to Chapter 9 (§ 36-141 et seq.) of Title 36 or those of
194 the Virginia Housing Development Authority.

195 6. Voluntary contributions to the Department for Aging and Rehabilitative Services.

196 a. All moneys contributed shall be used by the Department for Aging and Rehabilitative Services for
197 the enhancement of transportation services for the elderly and disabled.

198 b. All moneys shall be deposited into a special fund known as the Transportation Services for the
199 Elderly and Disabled Fund. All moneys so deposited in the fund shall be used by the Department for
200 Aging and Rehabilitative Services for the enhancement of transportation services for the elderly and
201 disabled. The Department for Aging and Rehabilitative Services shall conduct an annual audit of the
202 moneys received pursuant to this subdivision and shall provide an evaluation of all programs funded
203 pursuant to this subdivision annually to the Secretary of Health and Human Resources.

204 7. Voluntary contribution to the Community Policing Fund.

205 a. All moneys contributed shall be used to provide grants to local law-enforcement agencies for the
206 purchase of equipment or the support of services, as approved by the Criminal Justice Services Board,
207 relating to community policing.

208 b. All moneys shall be deposited into a special fund known as the Community Policing Fund. All
209 moneys deposited in such fund shall be used by the Department of Criminal Justices Services for the
210 purposes set forth herein.

211 8. Voluntary contribution to promote the arts.

212 All moneys contributed shall be used by the ~~Virginia Arts Foundation~~ to assist the Virginia
213 Commission for the Arts in its statutory responsibility of promoting the arts in the Commonwealth. All
214 moneys shall be deposited into a special fund known as the ~~Virginia Arts Foundation~~ *Commission for*
215 *the Arts* Fund.

216 9. Voluntary contribution to the Historic Resources Fund.

217 All moneys contributed shall be deposited in the Historic Resources Fund established pursuant to
218 § 10.1-2202.1.

219 10. Voluntary contribution to the Virginia Foundation for the Humanities and Public Policy.

220 All moneys contributed shall be paid to the Virginia Foundation for the Humanities and Public
221 Policy. All moneys shall be deposited into a special fund known as the Virginia Humanities Fund.

222 11. Voluntary contribution to the Center for Governmental Studies.

223 All moneys contributed shall be paid to the Center for Governmental Studies, a public service and
224 research center of the University of Virginia. All moneys shall be deposited into a special fund known
225 as the Governmental Studies Fund.

226 12. Voluntary contribution to the Law and Economics Center.

227 All moneys contributed shall be paid to the Law and Economics Center, a public service and
228 research center of George Mason University. All moneys shall be deposited into a special fund known
229 as the Law and Economics Fund.

230 13. Voluntary contribution to Children of America Finding Hope.

231 All moneys contributed shall be used by Children of America Finding Hope (CAFH) in its programs
232 which are designed to reach children with emotional and physical needs.

233 14. Voluntary contribution to 4-H Educational Centers.

234 All moneys contributed shall be used by the 4-H Educational Centers throughout the Commonwealth
235 for their (i) educational, leadership, and camping programs and (ii) operational and capital costs. The
236 State Treasurer shall pay the moneys to the Virginia 4-H Foundation in Blacksburg, Virginia.

237 15. Voluntary contribution to promote organ and tissue donation.

238 a. All moneys contributed shall be used by the Virginia Transplant Council to assist in its statutory
239 responsibility of promoting and coordinating educational and informational activities as related to the
240 organ, tissue, and eye donation process and transplantation in the Commonwealth of Virginia.

241 b. All moneys shall be deposited into a special fund known as the Virginia Donor Registry and
242 Public Awareness Fund. All moneys deposited in such fund shall be used by the Virginia Transplant
243 Council for the purposes set forth herein.

16. Voluntary contributions to the Virginia War Memorial division of the Department of Veterans Services and the National D-Day Memorial Foundation.

All moneys contributed shall be used by the Virginia War Memorial division of the Department of Veterans Services and the National D-Day Memorial Foundation in their work through each of their respective memorials. The State Treasurer shall divide the moneys into two equal portions and pay one portion to the Virginia War Memorial division of the Department of Veterans Services and the other portion to the National D-Day Memorial Foundation.

17. Voluntary contribution to the Virginia Federation of Humane Societies.

All moneys contributed shall be paid to the Virginia Federation of Humane Societies to assist in its mission of saving, caring for, and finding homes for homeless animals.

18. Voluntary contribution to the Tuition Assistance Grant Fund.

a. All moneys contributed shall be paid to the Tuition Assistance Grant Fund for use in providing monetary assistance to residents of the Commonwealth who are enrolled in undergraduate or graduate programs in private Virginia colleges.

b. All moneys shall be deposited into a special fund known as the Tuition Assistance Grant Fund. All moneys so deposited in the Fund shall be administered by the State Council of Higher Education for Virginia in accordance with and for the purposes provided under the Tuition Assistance Grant Act (§ 23.1-628 et seq.).

19. Voluntary contribution to the Spay and Neuter Fund.

All moneys contributed shall be paid to the Spay and Neuter Fund for use by localities in the Commonwealth for providing low-cost spay and neuter surgeries through direct provision or contract or each locality may make the funds available to any private, nonprofit sterilization program for dogs and cats in such locality. The Tax Commissioner shall determine annually the total amounts designated on all returns from each locality in the Commonwealth, based upon the locality that each filer who makes a voluntary contribution to the Fund lists as his permanent address. The State Treasurer shall pay the appropriate amount to each respective locality.

20. Voluntary contribution to the Virginia Commission for the Arts.

All moneys contributed shall be paid to the Virginia Commission for the Arts.

21. Voluntary contribution for the Department of Emergency Management.

All moneys contributed shall be paid to the Department of Emergency Management.

22. Voluntary contribution for the cancer centers in the Commonwealth.

All moneys contributed shall be paid equally to all entities in the Commonwealth that officially have been designated as cancer centers by the National Cancer Institute.

23. Voluntary contribution to the Brown v. Board of Education Scholarship Program Fund.

a. All moneys contributed shall be paid to the Brown v. Board of Education Scholarship Program Fund to support the work of and generate nonstate funds to maintain the Brown v. Board of Education Scholarship Program.

b. All moneys shall be deposited into the Brown v. Board of Education Scholarship Program Fund as established in § 30-231.4.

c. All moneys so deposited in the Fund shall be administered by the State Council of Higher Education in accordance with and for the purposes provided in Chapter 34.1 (§ 30-231.01 et seq.) of Title 30.

24. Voluntary contribution to the Martin Luther King, Jr. Living History and Public Policy Center.

All moneys contributed shall be paid to the Board of Trustees of the Martin Luther King, Jr. Living History and Public Policy Center.

25. Voluntary contribution to the Virginia Caregivers Grant Fund.

All moneys contributed shall be paid to the Virginia Caregivers Grant Fund established pursuant to § 63.2-2202.

26. Voluntary contribution to public library foundations.

All moneys contributed pursuant to this subdivision shall be deposited into the state treasury. The Tax Commissioner shall determine annually the total amounts designated on all returns for each public library foundation and shall report the same to the State Treasurer. The State Treasurer shall pay the appropriate amount to the respective public library foundation.

27. Voluntary contribution to Celebrating Special Children, Inc.

All moneys contributed shall be paid to Celebrating Special Children, Inc. and shall be deposited into a special fund known as the Celebrating Special Children, Inc. Fund.

28. Voluntary contributions to the Department for Aging and Rehabilitative Services.

a. All moneys contributed shall be used by the Department for Aging and Rehabilitative Services for providing Medicare Part D counseling to the elderly and disabled.

b. All moneys shall be deposited into a special fund known as the Medicare Part D Counseling Fund. All moneys so deposited shall be used by the Department for Aging and Rehabilitative Services to

305 provide counseling for the elderly and disabled concerning Medicare Part D. The Department for Aging
306 and Rehabilitative Services shall conduct an annual audit of the moneys received pursuant to this
307 subdivision and shall provide an evaluation of all programs funded pursuant to the subdivision to the
308 Secretary of Health and Human Resources.

309 29. Voluntary contribution to community foundations.

310 All moneys contributed pursuant to this subdivision shall be deposited into the state treasury. The
311 Tax Commissioner shall determine annually the total amounts designated on all returns for each
312 community foundation and shall report the same to the State Treasurer. The State Treasurer shall pay the
313 appropriate amount to the respective community foundation. A "community foundation" shall be defined
314 as any institution that meets the membership requirements for a community foundation established by
315 the Council on Foundations.

316 30. Voluntary contribution to the Virginia Foundation for Community College Education.

317 a. All moneys contributed shall be paid to the Virginia Foundation for Community College Education
318 for use in providing monetary assistance to Virginia residents who are enrolled in comprehensive
319 community colleges in Virginia.

320 b. All moneys shall be deposited into a special fund known as the Virginia Foundation for
321 Community College Education Fund. All moneys so deposited in the Fund shall be administered by the
322 Virginia Foundation for Community College Education in accordance with and for the purposes
323 provided under the Community College Incentive Scholarship Program (former § 23-220.2 et seq.).

324 31. Voluntary contribution to the Middle Peninsula Chesapeake Bay Public Access Authority.

325 All moneys contributed shall be paid to the Middle Peninsula Chesapeake Bay Public Access
326 Authority to be used for the purposes described in § 15.2-6601.

327 32. Voluntary contribution to the Breast and Cervical Cancer Prevention and Treatment Fund.

328 All moneys contributed shall be paid to the Breast and Cervical Cancer Prevention and Treatment
329 Fund established pursuant to § 32.1-368.

330 33. Voluntary contribution to the Virginia Aquarium and Marine Science Center.

331 All moneys contributed shall be paid to the Virginia Aquarium and Marine Science Center for use in
332 its mission to increase the public's knowledge and appreciation of Virginia's marine environment and
333 inspire commitment to preserve its existence.

334 34. Voluntary contribution to the Virginia Capitol Preservation Foundation.

335 All moneys contributed shall be paid to the Virginia Capitol Preservation Foundation for use in its
336 mission in supporting the ongoing restoration, preservation, and interpretation of the Virginia Capitol
337 and Capitol Square.

338 35. Voluntary contribution for the Secretary of Veterans and Defense Affairs.

339 All moneys contributed shall be paid to the Office of the Secretary of Veterans and Defense Affairs
340 for related programs and services.

341 C. Subject to the provisions of subsection A, the following voluntary contributions shall appear on
342 the individual income tax return and are eligible to receive tax refund contributions or by making
343 payment to the Department if the individual is not eligible to receive a tax refund pursuant to § 58.1-309
344 or if the amount of such tax refund is less than the amount of the voluntary contribution:

345 1. Voluntary contribution to the Family and Children's Trust Fund of Virginia.

346 All moneys contributed shall be paid to the Family and Children's Trust Fund of Virginia.

347 2. Voluntary Chesapeake Bay restoration contribution.

348 a. All moneys contributed shall be used to help fund Chesapeake Bay and its tributaries restoration
349 activities in accordance with tributary plans developed pursuant to Article 7 (§ 2.2-215 et seq.) of
350 Chapter 2 of Title 2.2 or the Chesapeake Bay Watershed Implementation Plan submitted by the
351 Commonwealth of Virginia to the U.S. Environmental Protection Agency on November 29, 2010, and
352 any subsequent revisions thereof.

353 b. The Tax Commissioner shall annually determine the total amount of voluntary contributions and
354 shall report the same to the State Treasurer, who shall credit that amount to a special nonreverting fund
355 to be administered by the Office of the Secretary of Natural and Historic Resources. All moneys so
356 deposited shall be used for the purposes of providing grants for the implementation of tributary plans
357 developed pursuant to Article 7 (§ 2.2-215 et seq.) of Chapter 2 of Title 2.2 or the Chesapeake Bay
358 Watershed Implementation Plan submitted by the Commonwealth of Virginia to the U.S. Environmental
359 Protection Agency on November 29, 2010, and any subsequent revisions thereof.

360 c. No later than November 1 of each year, the Secretary of Natural and Historic Resources shall
361 submit a report to the House Committee on Agriculture, Chesapeake and Natural Resources; the Senate
362 Committee on Agriculture, Conservation and Natural Resources; the House Committee on
363 Appropriations; the Senate Committee on Finance and Appropriations; and the Virginia delegation to the
364 Chesapeake Bay Commission, describing the grants awarded from moneys deposited in the fund. The
365 report shall include a list of grant recipients, a description of the purpose of each grant, the amount
366 received by each grant recipient, and an assessment of activities or initiatives supported by each grant.

The report shall be posted on a website maintained by the Secretary of Natural and Historic Resources, along with a cumulative listing of previous grant awards beginning with awards granted on or after July 1, 2014.

3. Voluntary Jamestown-Yorktown Foundation Contribution.

All moneys contributed shall be used by the Jamestown-Yorktown Foundation for the Jamestown 2007 quadricentennial celebration. All moneys shall be deposited into a special fund known as the Jamestown Quadricentennial Fund. This subdivision shall be effective for taxable years beginning before January 1, 2008.

4. State forests voluntary contribution.

a. All moneys contributed shall be used for the development and implementation of conservation and education initiatives in the state forests system.

b. All moneys shall be deposited into a special fund known as the State Forests System Fund, established pursuant to § 10.1-1119.1. All moneys so deposited in such fund shall be used by the State Forester for the purposes set forth herein.

5. Voluntary contributions to Uninsured Medical Catastrophe Fund.

All moneys contributed shall be paid to the Uninsured Medical Catastrophe Fund established pursuant to § 32.1-324.2, such funds to be used for the treatment of Virginians sustaining uninsured medical catastrophes.

6. Voluntary contribution to local school divisions.

a. All moneys contributed shall be used by a specified local public school foundation as created by and for the purposes stated in § 22.1-212.2:2.

b. All moneys collected pursuant to subdivision 6 a or through voluntary payments by taxpayers designated for a local public school foundation over refundable amounts shall be deposited into the state treasury. The Tax Commissioner shall determine annually the total amounts designated on all returns for each public school foundation and shall report the same to the State Treasurer. The State Treasurer shall pay the appropriate amount to the respective public school foundation.

c. In order for a public school foundation to be eligible to receive contributions under this section, school boards must notify the Department during the taxable year in which they want to participate prior to the deadlines and according to procedures established by the Tax Commissioner.

7. Voluntary contribution to Home Energy Assistance Fund.

All moneys contributed shall be paid to the Home Energy Assistance Fund established pursuant to § 63.2-805, such funds to be used to assist low-income Virginians in meeting seasonal residential energy needs.

8. Voluntary contribution to the Virginia Military Family Relief Fund.

a. All moneys contributed shall be paid to the Virginia Military Family Relief Fund for use in providing assistance to military service personnel on active duty and their families for living expenses including, but not limited to, food, housing, utilities, and medical services.

b. All moneys shall be deposited into a special fund known as the Virginia Military Family Relief Fund, established and administered pursuant to § 44-102.2.

9. Voluntary contribution to the Federation of Virginia Food Banks.

All moneys contributed shall be paid to the Federation of Virginia Food Banks, a Partner State Association of Feeding America. The Federation of Virginia Food Banks shall as soon as practicable make an equitable distribution of all such moneys to the Blue Ridge Area Food Bank, Capital Area Food Bank, Feeding America Southwest Virginia, FeedMore, Inc., Foodbank of Southeastern Virginia and the Eastern Shore, Fredericksburg Area Food Bank, or Virginia Peninsula Foodbank.

The Secretary of Finance may request records or receipts of all distributions by the Federation of Virginia Food Banks of such moneys contributed for purposes of ensuring compliance with the requirements of this subdivision.

D. Unless otherwise specified and subject to the requirements in § 58.1-344.2, all moneys collected for each entity in subsections B and C shall be deposited into the state treasury. The Tax Commissioner shall determine annually the total amount designated for each entity in subsections B and C on all individual income tax returns and shall report the same to the State Treasurer, who shall credit that amount to each entity's respective special fund.

2. That §§ 23.1-3225 and 23.1-3226 of the Code of Virginia are repealed.
