75 and that each house shall be notified of said nominations, and when the rolls shall be called for the
76 whole number, the presiding officers of each house shall appoint a committee of three, which together
77 shall constitute the joint committee to count the vote of each house in each case and report the results to
78 their respective houses. The joint order may be suspended by the presiding officer of either house at any
79 time but for no longer than twenty-four hours to receive the report of the joint committee.
