Estimate of Local Fiscal Impact

In accordance with the provisions of §30-19.03 of the Code of Virginia, the staff of the Commission on Local Government offers the following analysis of the above-referenced legislation:

Bill Summary:

School boards; teachers; planning time and planning periods. Requires each local school board to ensure that each elementary school teacher is provided an average of one 45-minute period per school day of planning time and that each middle and high school teacher is provided an average of one planning period per school day, which shall be at least 45 minutes or one class period, whichever is longer. The bill permits local school boards and teachers to enter into an appropriate contractual arrangement providing for compensation in lieu of such planning time or period. Under current law, public elementary school teachers are guaranteed at least an average of 30 minutes of planning time per school day during a school week.

Executive Summary:

Localities have evaluated a negative fiscal impact ranging from \$0 - \$0.75 million.

Most localities reported a fiscal impact of \$0, as they already meet the requirements posed by the bill. Only one locality indicated a negative fiscal impact, due to the necessary changes in bell schedules and school day hours; additionally, the locality noted the need to hire additional teachers if class times were extended.

The proposed legislation impacts cities and counties only, as schools are not a function of towns.

Local Analysis:

Locality: City of Danville Estimated Fiscal Impact: \$0.00

In Danville Public Schools, all K-8 grade teachers have at least 45 minutes per day for planning time. In grades K-5, teachers have at least 45 minutes and in grades 6-8, teachers have at least 90 minutes. Therefore, the bill will not impact K-8 grade teachers in Danville Public Schools. In fact, it will support Danville Public Schools' belief in providing teachers with appropriate time for daily planning.

Locality: City of Harrisonburg Estimated Fiscal Impact: \$0.00

The school system already operates on a shortened instructional day, meaning that staff easily meet the planning time requirement. There is no fiscal impact, but there may be an impact on student learning due to less direct instructional time.
